



DAYCARE CONSENT AND AGREEMENT

Daycare at Four Seasons Animal Hospital is a service we are glad to provide for our clients. We must keep in mind that this facility is an Animal Hospital that provides Daycare services, and not just a kennel. In order to establish a safe and healthy environment for all participants in the daycare program, we require the following preventative medicine measures to be current to protect daycare animals from infectious disease:

Vaccinations: Dogs: Rabies (3 year or 1 year), DHPP (Distemper, Hepatitis, Parainfluenza, Parvovirus), Bordetella bronchiseptica (kennel cough), H3N2 (influenza)

Cats: Rabies (3 year or 1 year), FVRCP Feline viral rhinotracheitis, Calicivirus, Panleukopenia)

Fecal/Internal Parasites: Due to the contagious nature of internal parasites (worms), all animals are required to have a fecal test current within the last year.

External Parasites: Fleas and ticks are contagious! On admission, your pet will be examined for external parasites. If any are found, we will give a 24-hour Capstar (flea/tick treatment) at the owner's expense, before the pet can be admitted into daycare. It is recommended that all pets be on a monthly preventative.

Health: All pets must be in good health and free from any communicable diseases that would jeopardize other pets for at least the previous 2 weeks. Because daycare involves play with other animals, it is required that all animals over the age of 6 months old, be spayed/ neutered. Unaltered animals will not be allowed to play in daycare with other animals.

Behavior: Dogs must not have a history of aggression towards people or other dogs. FSAH reserves the right to decline services to any animal that has shown aggression (growling, nipping, lunging, etc.) for the safety of the other animals.

Emergencies: In the event of a life-threatening emergency, FSAH will treat your pet with the limited treatment necessary for life saving measures. The staff will attempt to contact you in advance to seek authorization and direction for treatment if time allows, but if you are unreachable or time does not allow, treatment will be performed at the expense of the client.

Special Pricing: Pre-payment of at least 5 days of a Daycare stay will yield a \$2.00 discount* for each day.

*Daycare while boarding is excluded from this pre-pay discount plan.

Social Media: We like to share pictures of our patients having fun on social media (Facebook, Instagram, etc) and would love to post pictures of your pet!
